Writ petition (civil) praying inter alia that in the circumstances stated in the affidavit filed along with the WP(C) the High Court be pleased to direct the respondents 1 to 8 not to levy GST for the insurance premium paid by the retirees and pensioners of commercial banks under IBA Group Medical Insurance policy, pending disposal of the above writ petition (c).

This petition coming on for orders upon perusing the petition and the affidavit filed in support of WP(C) and upon hearing the arguments of M/S. V.M.KRISHNAKUMAR, DR.SILPA AZIZ, Advocates for the petitioners, the court passed the following:

ORDER

Admit.

2. The learned Central Government Counsel takes notice for the 1st respondent. Adv.M. Gopikrishnan, the learned Standing Counsel takes notice for the respondent Nos. 2 and 5. Issue urgent notice by speed post to respondent Nos. 3,6, and 7. Adv.George A. Cherian, the learned Standing Counsel takes notice for the 8th respondent. The learned Standing Counsel takes notice for the 4th respondent.

3. Adv.George Cherian (Thiruvalla), the learned Senior Counsel appearing for the 8th respondent, pointed out that the exemption claimed by the petitioner is not applicable to them, in view of the fact that what is contemplated in the exemption notification is the individual policy, which at the most, would take in, the family of that particular individual. It was further contended that the group policies are specifically exempted from the purview of the same. Therefore, it was contented that the claim of the petitioner cannot be entertained.

4. However, I am of the view that since I have already admitted similar writ petitions and granted interim orders, an interim order can be granted in this writ petition also. The issue raised by the learned Senior Counsel for the 6th respondent can be considered after hearing the

matter in detail.

5. Thus, there shall be an interim order, directing the respondents to renew the policies of the petitioners for the current year without insisting on GST. However, it is clarified that this shall be subject to further orders to be passed by this Court.
